Components:	The ORF clone is ion-exchange column purified and shipped in a 2D barcoded Matrix tube containing 10ug of transfection-ready, dried plasmid DNA (reconstitute with 100 ul of water).
Reconstitution Method:	<ol> <li>Centrifuge at 5,000xg for 5min.</li> <li>Carefully open the tube and add 100ul of sterile water to dissolve the DNA.</li> <li>Close the tube and incubate for 10 minutes at room temperature.</li> <li>Briefly vortex the tube and then do a quick spin (less than 5000xg) to concentrate the liquid at the bottom.</li> <li>Store the suspended plasmid at -20°C. Gene Summary:	CHCHD4, a component of human mitochondria, belongs to a protein family whose members share 6 highly conserved cysteine residues constituting a -CXC-CX(9)C-CX(9)C- motif in the C terminus (Hofmann et al., 2005 [PubMed 16185709]).[supplied by OMIM, Mar 2008] Transcript Variant: This variant (2) contains an alternate segment for the 5' coding region and uses a downstream start codon, compared to variant 1. Variant 2 is found at a much lower frequency than variant 1. The predicted protein (isoform 2) is longer and has a distinct and longer N-terminus, compared to isoform 1.
