Summary: This gene encodes a member of the WAP-type four-disulfide core (WFDC) domain family. The

WFDC domain, or WAP signature motif, contains eight cysteines forming four disulfide bonds

at the core of the protein, and functions as a protease inhibitor. The encoded protein

contains four WFDC domains. Most WFDC genes are localized to chromosome 20q12-q13 in

two clusters: centromeric and telomeric. This gene belongs to the telomeric cluster.


Alternatively spliced transcript variants have been observed but their full-length nature has

not been determined. [provided by RefSeq, Jul 2008]

shRNA Design: These shRNA constructs were designed against multiple splice variants at this gene locus. To

Performance Guaranteed:

OriGene guarantees that the sequences in the shRNA expression cassettes are verified to correspond to the target gene with 100% identity. One of the four constructs at minimum are guaranteed to produce 70% or more gene expression knock-down provided a minimum transfection efficiency of 80% is achieved. Western Blot data is recommended over qPCR to evaluate the silencing effect of the shRNA constructs 72 hrs post transfection. To properly assess knockdown, the gene expression level from the included scramble control vector must be used in comparison with the target-specific shRNA transfected samples.

For non-conforming shRNA, requests for replacement product must be made within ninety (90) days from the date of delivery of the shRNA kit.
