**Summary:** The protein encoded by this gene shares considerable sequence similarity to, and is

structurally related to DNase II. The latter is a well characterized endonuclease that catalyzes DNA hydrolysis in the absence of divalent cations at acidic pH. Unlike DNase II which is

ubiquitously expressed, expression of this gene product is restricted to the salivary gland and

lungs. The gene has been localized to chromosome 1p22.3 adjacent (and in opposite

orientation) to the uricase pseudogene. Two transcript variants encoding different isoforms

have been described for this gene. [provided by RefSeq, Jul 2008]

# Performance Guaranteed:

OriGene guarantees that the sequences in the shRNA expression cassettes are verified to correspond to the target gene with 100% identity. One of the four constructs at minimum are guaranteed to produce 70% or more gene expression knock-down provided a minimum transfection efficiency of 80% is achieved. Western Blot data is recommended over qPCR to evaluate the silencing effect of the shRNA constructs 72 hrs post transfection. To properly assess knockdown, the gene expression level from the included scramble control vector must be used in comparison with the target-specific shRNA transfected samples.

For non-conforming shRNA, requests for replacement product must be made within ninety (90) days from the date of delivery of the shRNA kit.
