**Summary:** Minor apolipoprotein mainly associated with HDL and to a lesser extent with VLDL. May also

be associated with chylomicrons. Important determinant of plasma triglyceride (TG) levels by

both being a potent stimulator of apo-CII lipoprotein lipase (LPL) TG hydrolysis and an

inhibitor of the hepatic VLDL-TG production rate (without affecting the VLDL-apoB production rate). Activates poorly lecithin: cholesterol acyltransferase (LCAT) and does not enhance efflux

## Performance Guaranteed:

OriGene guarantees that the sequences in the shRNA expression cassettes are verified to correspond to the target gene with 100% identity. One of the four constructs at minimum are guaranteed to produce 70% or more gene expression knock-down provided a minimum transfection efficiency of 80% is achieved. Western Blot data is recommended over qPCR to evaluate the silencing effect of the shRNA constructs 72 hrs post transfection. To properly assess knockdown, the gene expression level from the included scramble control vector must be used in comparison with the target-specific shRNA transfected samples.

For non-conforming shRNA, requests for replacement product must be made within ninety (90) days from the date of delivery of the shRNA kit.
