### 2.1 Classification of the substance or mixture

More recent generation vectors have been designed to diminish possible recombination resulting in a wild type-potentially infectious virus. It is usually recommended that work with nonhuman lentiviruses that are incapable of establishing productive infections in humans be conducted at BSL-2.
